

一、申請資格 / Qualifications

1.具外國國籍且未曾具有中華民國國籍,於申請時並不具僑生資格者,得依本簡章規定申請入學(不含港澳生)。

具外國國籍且符合下列規定,於申請時並已連續居留海外(不含大陸、香港及澳門)6年以 上者,亦得依本簡章規定申請入學:

- (1) 申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。
- (2) 申請前曾兼具中華民國國籍者,應於申請時已放棄中華民國國籍滿8年以上。
- (3)前二款均未曾以僑生身分在臺就學,且未於當學年度接受海外聯合招生委員會分發者。 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或 海外連續居留滿6年以上者,得依本簡章規定申請入學:

曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留滿6年以上者,得依本簡章規定申請入學:

Foreign students who are neither citizens of the Republic of China (R.O.C.), nor Overseas Chinese Students may apply for admission according to the regulations of this brochure. These regulations are not applicable for those who are citizens of Hong Kong or Macao.

Foreign students who had stayed abroad (Mainland China, Hong Kong, and Macao are excluded) for more than 6 years and meet the following conditions may also apply for admission according to the regulations of this brochure.

- (1) While applying, foreign students currently have the nationality of R.O.C. must NEVER establish any household registration in Taiwan.
- (2) Before applying, foreign students used to have the nationality of R.O.C. must have abdicated their R.O.C. nationality for more than 8 years.
- (3) Applicants in the preceding subparagraph 1 and subparagraph 2 shall NEVER study in Taiwan as Overseas Chinese Students, also can **NOT** apply for admission to the "University Entrance Committee for Overseas Chinese Students" (http://www.overseas.ncnu.edu.tw/) this year.

An applicant of foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macao, having no history of a household registration record in Taiwan and, at the time of application, has resided in Hong Kong, Macao, or another foreign country for no less than 6 years is qualified to apply for admission.

An applicant being a former citizen of Mainland China and holds a foreign nationality, having no history of household registration record in Taiwan, and has resided overseas continuously for no less than 6 years is qualified to apply for admission.

2.外國學生須符合教育部採認之高中、大學或獨立學院畢業者。外國學生具高中畢業資格者,得申請入學本校四年制修讀學士學位;具學士學位者,得申請入學本校碩士班;具碩士學位者,得申請入學本校博士班。

International students who have graduated from a high school, college or university recognized by the Ministry of Education of R.O.C., can apply for admission. (please refer to the website http://www.edu.tw/). International students with a high school diploma are eligible to apply for the four-year undergraduate programs; students with a bachelor's degree are eligible to apply for the master's programs; students with a master's degree are eligible to apply for the doctoral programs.

3.與本校簽有雙聯學制協議之外國學校申請生得比照本簡章申請入學本校。
Students from the foreign universities with agreement of dual degree program with CYUT may apply according to this brochure.

4.已在臺就讀其他大專校院之外籍學生,得比照本簡章申請入學本校,惟須另行檢附該大專校院之在學證明及歷年成績單。

Foreign students currently enrolled in other universities in Taiwan may apply for CYUT admission according to this brochure with certificate of enrollment and transcript officially provided during application.

- 2.經我國駐外使館、代表處、辦事處、或其他經外交部授權機構(以下簡稱駐外館處)驗證之外國學校最高學歷證明文件及成績單(中、英文以外之語文,應附經公證之中文或英文譯本)。 Copy of the highest academic diploma and the transcripts of the highest educational degree (notarized copy translated into English or Chinese is necessary if the original document is not in English or Chinese) authenticated by R.O.C. embassies, representative, consulates, or other Mission authorized by Taiwan Ministry of Foreign Affairs (hereandafter referred to as Taiwan Overseas Mission).
- 3.經駐外館處驗證、或開戶銀行擔保的財力證明書。
 Financial Statement of sufficient funds verified / sealed by the Taiwan Overseas Mission, or with an official stamp by the bank.
- 4. 護照影印本或其他國籍證明文件。

Photocopy of passport or other equivalent verification of nationality.

- 5.語言成績證明,華語文測驗成績B1;就讀英語授課學程(含碩、博士)及母語為華語者免檢附。 Language Proficiency Certificate - TOCFL B1. Students who applied for an English-taught programs (including Master and Ph.D.) and native Chinese speakers are exception.
- ※各系所若有特別要求資料,將另行通知補繳。

Additional documents may be required by departments / institutes; in this case, applicants will be notified as needed.

五、其他申請注意事項 / Other Important Issues

- 1.同時申請一個以上系所者,僅能選擇其中一系所報到註冊。
 - Applicants who apply for more than one program can only register into one of them.
- 2.報名時繳交之「畢業證書」及「歷年成績單」,除海外臺灣學校所發者外,應依教育部「大 學辦理國外學歷採認辦法」規定辦理。
 - The diploma and transcript submitted for application review shall first be authenticated in accordance with the rules promulgated by the Ministry of Education, R.O.C. Taiwan, except for diplomas and transcripts issued by Overseas Taiwanese or Overseas Chinese schools.
- 3.依教育部規定,凡曾經入學學校以操行、學業成績不及格或因犯刑事案件經判刑確定致遭退 學者,不得再向本校申請入學。若違反此規定並經查證屬實者,取銷其入學資格。

In accordance with the Ministry of Education regulations, those who have been dropped out of or withdrawn from school due to failure of their conduct, failure of their academic grade, or found guilty of criminal cases are **NOT** eligible to apply.

- Applicants who violate this regulation will have their admission nullified or status as a Chaoyang University of Technology (CYUT) student revoked.

- 5.已報名或錄取之學生,如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、冒用等不實情事者,未入學者即取消錄取資格;已入學者開除學籍,亦不發給任何學歷證明;如將來在本校畢業後始發現者,除勒令繳銷其學位證書外,並公告取消其畢業資格。 Admission shall be denied and / or the student shall be dismissed from CYUT after admission if there are any violations of the general academic honor code and / or in the authenticity of the applicant's documents. Those who have graduated shall have their diploma revoked.
- 6.依規定,凡申請來來居留簽證,須檢具麻疹及德國麻疹抗體陽性報告或預防接種證明。 According to the regulations, students who apply for a resident visa must submit a medical report including the vaccination certificates of Measles and Rubella or their positive antibody titers.
- 7.所有新生於註冊時,都須投保本校傷病醫療險,以確保在發生意外傷害、或其他醫療需求時, 有足夠的保險理賠金額,支付相關費用。
 - All international students are required to purchase a mandatory medical insurance while registered as a full-time CYUT degree student.
- 8.外國學生就學期間在臺設戶籍登記、戶籍遷入登記、歸化或回復中華民國國籍者,喪失外國學生身分,需經退學處分。
 - International students will be withdrawn from CYUT if their identities of international students have been lapsed by establishing household registrations, moving-in registrations, naturalizing or regaining R.O.C Taiwan citizenships.

六、招生系所及招生名額 / Academic Programs and Admission Quota

- 1.招生名額:大學部226位、碩士班42位、博士班10位。
 - The admission quota of Bachelor degree is 226, Master degree is 42, and Doctoral degree is 10.
- 2.本校目前有管理、理工、設計、人文暨社會、資訊等5個學院,計有22個大學部,22個碩士班、5個博士班學程,均開放招收外國學生。
 - CYUT has five colleges: Management, Science and Engineering, Design, Humanities and Social Sciences, and Informatics, with a total of 22 undergraduate programs, 22 master's degree programs, and 5 doctoral programs. All programs accept international student applications.

七、獎學金 / Scholarship

外國學生入學後,得向本校國際暨兩岸合作處申請獎助學金。本校每年提供超過千萬元之國際學生獎學金,成績優異之國際學生可獲全額獎學金;詳細辦法請查詢本校獎學金網址 http://www.icsc.cvut.edu.tw/service/153。

依朝陽科技大學外國學生獎助學金設置辦法分為以下兩部分:

- 一、大學部:每名學生得申請成績績優獎學金,並以每學期申請1次為原則。大學部學生至多 得申請8次。
- 二、研究所:每名學生得申請成績績優獎學金,以每學期申請1次為原則。碩士生至多得申請 4次;博士生至多得申請8次。

此外,外國學生亦可申請政府核發之臺灣獎助學金,相關資訊請參閱官方網站 http://tafs.mofa.gov.tw/Schs.aspx?loc=en。

Registered international students can apply to the Office of International and Cross-strait Cooperation for CYUT scholarships. CYUT offers more than 10 million New Taiwan Dollars of scholarship for international students. Successful applicants will be eligible to award a full tuition waiver while studying at CYUT. According to the Regulations Governing Scholarship Program for Foreign Students at CYUT, scholarships are divided into 2 categories, as follows:

- A. For undergraduates: students can apply for CYUT scholarship based on academic performance and are limited to one application per semester. Students at undergraduate level are limited to a maximum of 8 applications.
- B. For postgraduates: students can apply for CYUT scholarship based on academic performance and are limited to one application per semester. Master students are limited to a maximum of 4 applications and Ph.D. students are limited to a maximum of 8.

八、報到註冊 / Registration

- 1.錄取生應依入學通知書之規定辦理報到註冊手續,並繳驗護照、畢業證書及成績單(須經臺灣駐外單位或代表處驗證蓋章),始得註冊入學。逾期未報到註冊者,取消入學資格。 Admitted student should arrive at the CYUT campus for registration prior to the date specified on the admission document. Passport and copies of diploma and transcripts, officially verified/sealed by the Taiwan Overseas Mission in the country where the documents were originally issued, should be presented. Admission is subject to cancellation if not registered.
- 2.經錄取學生註冊入學後,其學分抵免悉依本校「學生抵免學分規則」辦理。
 Transfer credits from other colleges / universities shall be ruled by the university credit-transfer regulations.

九、學雜費標準 / Tuition and Incidental Fees

十、住宿與生活費 / Dormitory and Living Expenses

- 1.外國學生經錄取得申請分配宿舍,宿舍費用4人房每學期約新台幣13,000元。 Foreign students may apply a room shared with 4 people. The dormitory expenses are about NT\$ 13,000 for 4-bed rooms per semester.
- 2.生活費每個月約新台幣6,000元~8,000元。 Living expenses range from NT\$6,000 to NT\$8,000 per month.

學生之個人資料蒐集、處理及利用告知事項

請詳細閱讀朝陽科技大學(以下簡稱本校)依「個人資料保護法」(以下簡稱個資法)第8條及第9條規定所為以下「學生之個人資料蒐集、處理及利用告知事項」。

- 一、組織名稱:朝陽科技大學。
- 二、個人資料蒐集之目的:

本校蒐集您個人資料的目的在於辦理學位生、雙聯學位、交換學生及其他入學申請相關作業, 且當錄取時轉入學生學籍資料。

三、個人資料之蒐集方式:

透過學生網路報名或書面遞交而取得學生個人資料。

- (一)透過學生報名申請參加本校招生委員會提供考生個人資料。
- (二)學生於本校招生資訊網路系統登錄或修改之各項相關資料。

四、個人資料之類別:

- (一)辨識個人者(C001)。
- (二)辨識財務者(C002)。
- (三)政府資料中之辨識者(C003)。
- (四)個人描述(C011)之性別、出生年月日、國籍。
- (五)家庭其他成員細節(C023)之監護人或緊急連絡人等。
- (六)移民情形(C033)之護照、居留證明文件。
- (七)學校紀錄(C051)、資格或技術(C052)。
- (八)學生、應考人紀錄 (C057)。

前項各款個人資料類別,內容包括姓名、護照或居留證或護照號碼、生日、相片、性別、教育資料、緊急聯絡人、住址、電子郵遞地址、聯絡資訊、轉帳帳戶、低收入戶或中低收入戶證明方式等。

五、個人資料處理及利用:

(一)個人資料利用之期間:

學生個人資料及相關申請資料,除法令或中央事業主管機關另有規定外,以上開蒐集目的完成所需之期間為利用期間。

- (二)個人資料利用之地區:臺灣地區或經學生授權處理、利用之地區。
- (三)個人資料利用之對象:除本校外,尚包括本於完成上開蒐集目的之相關合作單位,包含 教育部或其他學術研究機構等。
- (四)個人資料利用之方式:

入學申請期間之行政作業與相關資訊之發送通知,提供作為錄取、報到、查驗及入學後活動辦理等作業,學生(或法定代理人)之聯絡,基於試務公信的必要揭露與學術研究及其他有助上開蒐集目的完成之必要方式。

- 六、學生如未提供真實且正確完整之個人資料,將導致無法進行報名、緊急事件無法聯繫、錄取通 知書無法送達等等,影響學生申請服務之權益。
- 七、學生應確認提供之個人資料,均為真實且正確;如有不實或需變更者,應即檢附相關證明文件 送本校辦理更正。
- 八、本校得依法令規定或主管機關或司法機關依法所為之要求,將個人資料或相關資料提供予相關 主管機關。
- 九、個人資料之權利及權益:您依法得行使個人資料保護法第3條之查閱、更正個資等權利,但因 法令另有規定者,本校得拒絕之。若因您行使上述權利,而導致權益受損時,本校將不負相關 賠償責任。
- 十、除法令另有規定或主管機關另有要求外,學生如提出停止蒐集、處理、利用或請求刪除個人資料之請求,經評估會妨礙本校執行職務或完成上開蒐集目的,或導致本校違背法令或主管機關之要求時,本校得繼續蒐集、處理、利用或保留個人資料。

Notification of the Collection, Processing and Use of Personal Information for Applicants

- 1. Please read carefully the notification of the Collection, Processing and Use of personal Information for Applicants of Chaoyang University of Technology (hereinafter referred to as the "University") according to the Articles 8 and 9 of the Personal Data Protection Law (hereinafter referred to as the "Act").
- 2. Purpose of collecting personal information:

The personal information is collected exclusively for the purposes of processing the application of degree, dual degree, and exchange student programs, as you are admitted and it will be transferred to student's personal information record.

3. Method of collecting personal information:

Personal information of applicants is collected from online registration or application made in person.

- a. Personal information is provided by the applicants while applying for the evaluation of the University's Recruitment Committee.
- b. Personal information that the applicants have logged in or edited on the University's online recruitment information system.
- 4. Basic information categories:

Personal information categories, such as individual identifier (C001), financial condition identifier (C002), identifier within government information (C003), personal profile (C011), Information on other family members(C023), immigration status(C033), school record (C051) and qualification or technique (C052), student and test participator record(C57), which entails name, number of resident certificate or passport, date of birth, photo, gender, education information, emergency contact, resident address, email address and contact information.

- 5. Processing and use of personal information:
 - a. The period within which the personal data can be used:

 Unless otherwise stipulated by the law or the central competent authority in respect of the retention period of personal information, the retention period of the personal information by the University shall be the time required for the above purposes for collection to be fulfilled.
 - b. The area where the personal information is used: Taiwan area or areas authorized by the applicant/student for processing and use.
 - c. Object of the use of personal information: The University or partnership institutions for completing the above collection purposes, including the Ministry of Education and other academic research institutions.
 - d. Methods of using the personal information:
 - Methods which are necessary for the admission, reporting to the University, verification, registration, management of new students by the University, contact with students/applicants (parents, guardians), and event participation which is required for the fulfillment of the above collection purposes.
- 6. The applicant's failure to provide true and complete personal information may lead to his or her inability to register for the application or to be contacted during emergency, or the failed delivery of admission notices, which will adversely affect the applicant's application services.
- 7. All applicants shall make sure that the personal information provided is true and accurate. If any personal information of the applicants is untrue or to be modified, the applicants shall promptly submit the relevant supporting document to the University for such correction.
- 8. The University may provide personal information or the relevant information according to the law or upon the request by the central competent authority or the judicial authority
- 9. The right & benefit of personal information: Applicants may request to inquire or correct the personal information, according to Article 3 of Personal Information Protection Act, except when allowed under other regulations, the University could reject your requests. Should you suffer any losses due to such requests, the University shall not be held responsible for any compensation.
- 10. If applicants request to stop collecting, processing, using or deleting personal information, which is assessed that could affect the University to execute or complete the above collection purposes or that would lead the University to disobey the laws or the requests of the authorities, the University should continue to collect, process, use or keep the personal information, except when allowed under other regulations or requested by the authorities.
